Thank you for your interest in our event, Rotary Spring Thing 2023. The event will take place on Saturday, March 18, 2023 from 11am - 6 pm at The Villages Polo Club. Set-up will take place between 9:00 am and 10:30 am on Saturday, March 18, 2023. *All vendors must be open for business for the entire length of the events from 11:00 am - 6:00 pm.* We will send load-in instructions and all other pertinent info to accepted vendors by Monday, March 13, 2023.
